ACWSA WI/IL Regional Meeting February 14. 2016



1. Commander Chabalowski called the meeting to order at 10:25 on Sunday, February 14 in the home of Stephen and Elaine Sherry in Burlington, WI. Many items, e.g. the 2016 Nationals and paper cartridges for revolvers, etc. were covered in the ACWSA Board meeting held just before this one, and those topics are covered the minutes of that meeting.

2. Old Business:

A. Paymaster Darlene Van Kauwenbergh collected 2016 team rosters and dues. Any dues submitted for veteran members after the meeting need to include a \$5 late fee.

- B. The group dispensed with the reading of our last minutes
- C. Paymaster Report The 2016 financial report was given during the Board Meeting, and is reported separately. The entire report is on the acwsa.org web site.

3. New Business

A. Team Reports – The group went around the table and gave status reports of their individual teams. Nothing earth shaking was reported. The 2nd WI reported about 5 losses, of which three were 'ghosts', i.e. non participants, with the exception of Nate and Angie Brown, who are moving to North Carolina. The 2nd USSS team merged into the 1st USSS, which is now led by Rick Riener (vice Pat Kaboskey). The 8th WI is down to 3 active shooters. The 56th VA confirmed they dropped their affiliation with the N-SSA, but all their members are still in the ACWSA.

Bob Chabalowski noted Les Knutsen years of service as regional IG, and thanked him for his service.

Note: National elections were held in February 2015. Two-year terms for Commander Chabalowski, Vice Commander Michael Zandarski, Adjutant Terry Arliskas and Paymaster Darlene Van Kauwenbergh began January 1, 2016, and the next national election will be at the 2017 annual meeting.

D. The proposed 2016 Skirmish Schedule was approved without changes. The dates are:

E. The 2016 ACWSA Nationals, Jun 10-12, near Bristol, IN was discussed in depth during the ACWSA Board meeting. Basically, the awards are done, the event flier almost completed – but needs some targeting and meal decisions before publishing. The budget is mostly complete, but small items are being added every time we talk.

F. acwsa.org Website: After being locked for about a half year, our old website was replaced in early December with a new one written using Word Press software. Word Press is free, easy to use, and so commonly used today we shouldn't have to do this again for over a decade. Rewriting the website took longer than expected because over 13 years of content needed to be reorganized and reformatted.

The intended audience for the website is both the public, and the entire ACWSA membership. While the Michigan region has its own Facebook page, the WI-IL currently does not. Most of the current content leans toward the WI-IL region. Future goals for the webmaster are to find an additional webmaster from the Michigan Region to broaden the content, and expand into some sort of blogging or forum where members can post on the site.

The new web page is nice, but with smart phones, young folks access Facebook more often than websites these days. Gary Van Kauwenbergh is willing to back-up someone else on a WI/IL Facebook page, but does not want to do it alone. Bob Chabalowski said he would contact Terry Skweres (15WI) about possibly hosting a WI/IL region Facebook page, similar to MI's page.

G. Possible New Range: The curator of the museum on Volk Field near Camp Douglas would like to explore us having an event at their facility now that it's not busy so busy with Middle East deployments. The ACWSA used to skirmish there every year until it was closed to outsiders. Their developed campground and picnic area are pretty much the same as when we left, but their shooting range has been revamped and now seems to be at least partially enclosed. Sometime during the next year Gary will tour the new facilities to see if it's suitable for skirmishing.
